Quotations may be submitted to the undersigned along with Demand Draft/Pay Order of Rs. 400/- (Rupees Four Hundred Only) EMD for above vehicle in favour of Comptroller, MAFSU, Nagpur as refundable security (EMD)
- 4) Incomplete quotations received will not be considered and shall not be accepted by the University.
- 5) The quotations addressed to the undersigned in a sealed envelope should reach this office latest by 5.00 pm on or before **29.05.2017** and shall be opened on **30.05.2017** at **12.00 noon**. Quotations should be submitted in the Directorate of Extension & Training, MAFSU, Futala Lake Road, Nagpur. The bidder or their authorized representative (not more than one) may witness the quotation opening at the time of opening the quotations.

TERMS AND CONDITIONS FOR DISPOSAL OF VEHICLE No. MH-31/AG-9635

Interested parties may submit their highest price for the vehicle in a sealed envelop latest **by 5:00 pm on or before 29.05.2017**. The inner envelope containing price quotations in Annexure-II should be sealed separately. The other relevant documents alongwith DD/Pay order/Bankers Cheque towards EMD should be sealed properly. The envelope should be put in another envelope and may be dropped in the office of Directorate, Extension & Training, Futala Lake Road, Nagpur. Both the inner and the outer envelops should be superscribed in Bold Capital Letters **“QUOTATIONS FOR DISPOSAL OF VEHICLE (Ambassador)”**.

2. The disposal of vehicle shall be strictly on **“AS IS WHERE IS BASIS”** and No Guarantee or certificate of its worthiness or quality will be given by this Department. The condition of the vehicles can be inspected physically between **20.05.2017 to 29.05.2017** between **11.30 am to 04.00 pm** at Directorate, Extension & Training, MAFSU, Futala Lake Road, Nagpur. The Vehicle will be available for inspection upto **29.05.2017**.
3. The quotation should be accompanied by earnest money of Rs. 400/- (Rupees Four Hundred Only). The earnest money can be deposited by Bank Draft in favour of Comptroller, MAFSU, Nagpur. The Bank Draft should be attached with the quotation letter failing which the quotation shall not be considered at all. The Highest offer of the vehicle will be traded as successful quotation provided the same is accepted by the competent authority of the office.
4. The successful bidder will be required to deposit the total bid amount by means of Demand Drafts in favour of Comptroller, Maharashtra Animal & Fishery Sciences University, Nagpur within **Seven working days** from the date of acceptance of the offer, failing which his earnest money will be forfeited. In case the offer is withdrawn by any bidder, the earnest money deposited by him shall be forfeited.
5. The successful bidder shall be required to submit documentary evidence in support of residential status (Ration Card/ Voters Identity Card/ Aadhar Card/ PAN Card in case of individual and Registration Certificate in case of firms etc.) along with duly filled in prescribed quotation form.
6. EMD of successful bidder(s) will be released only after realization of Sale proceed amount. Earnest money deposit of the bidders who fail to honour the bid in prescribed time limit shall stand forfeited. No representation in this regard shall be entertained by this office. EMD amount of the successful bidder(s) shall be released only after successful completion of the sale process.

7. The sold vehicle will be removed by the successful bidder(s) within 48 hours of depositing the money at their own expenses after that a penalty of Rs. 500/-per day will be charged. Local Sales Tax will have to be paid by the successful bidder over and above his offer as per government Rules. No assistance/ transportation will be provided by MAFSU, Nagpur. Permission to take out the disposed vehicle from Shetkari Bhawan premises will not be allowed on holidays, Saturdays and Sundays etc.
